BRIEF HISTORY

The ISO Recommendation R 1105, *Pesticides considered not to require common names—Second list*, was drawn up by Technical Committee ISO/TC 81, *Common names for pesticides*, the Secretariat of which is held by the British Standards Institution (BSI).

Work on this question led to the adoption of a Draft ISO Recommendation.

In November 1967, this Draft ISO Recommendation (No. 1046) was circulated to all the ISO Member Bodies for enquiry. It was approved, subject to a few modifications of an editorial nature, by the following Member Bodies:

No Member Body opposed the approval of the Draft.

The Draft ISO Recommendation was then submitted by correspondence to the ISO Council which decided, in September 1969, to accept it as an ISO RECOMMENDATION.

FOREWORD

This ISO Recommendation gives the Second List of pesticide chemicals with reasonably short and distinctive chemical names or trivial names already known, to which it is deemed unnecessary to assign recommended common names at present.

The intention is that all the members of the group of isomers of the same pesticide are included in this list and, in consequence, it is not necessary to add any locants to the chemical names.
