BRIEF HISTORY

The ISO Recommendation R 657/III, *Dimensions of hot-rolled steel sections – Equal-leg angles – Inch series – Dimensions and sectional properties*, was drawn up by Technical Committee ISO/TC 17, *Steel*, the Secretariat of which is held by the British Standards Institution (BSI).

Work on this question led in 1967 to the adoption of a Draft ISO Recommendation.

In December 1967, this Draft ISO Recommendation (No. 1372) was circulated to all the ISO Member Bodies for enquiry. It was approved, subject to a few modifications of an editorial nature, by the following Member Bodies :

No Member Body opposed the approval of the Draft.

The Draft ISO Recommendation was then submitted by correspondence to the ISO Council, which decided, in March 1969, to accept it as an ISO RECOMMENDATION.
